



Website Privacy Policy

This privacy policy sets out how Red Robin Therapy uses and protects any information that you give us when using this website.

Red Robin Therapy is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, you can be assured that it will only be used in accordance with this privacy statement.

Red Robin Therapy reserves the right, at its discretion, to make changes to any part of the Website, the Information or these Terms. Red Robin Therapy may change this policy from time to time by updating this page. It is important you check this page from time to time to ensure that you are happy with any changes.

This policy came into effect from May 2018 and was reviewed in September 2020. By continuing to use the Website you agree to be bound by these Terms as amended.

What we collect

Red Robin Therapy does not collect any information which identifies you as an individual ("Personal Information"), such as your name, email address and phone number. The website directs you to telephone and email contact, and all downloadable resources are freely available without registration details.

Security

We are committed to ensuring that your information is secure. In the event of collecting any personal data in the future, and to prevent unauthorised access or disclosure, we have put in place highly secure electronic systems and managerial procedures to safeguard and secure any information we may collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site or page. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. Red Robin Therapy use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
